

TTTFP POLICY GOAL

Harmonisation in respect of inter-state road transport policies, laws, regulations, standards and systems for efficient cross border road transport and transit networks, transport and logistics services, systems and procedures in the East and Southern Africa region [COMESA, EAC and **SADC1**

TTTFP STRATEGY

Facilitate the development of a more competitive, integrated and liberalised regional road transport market in the East and Southern African region, based on the principle of variable geometry in the region

TTTFP PRINCIPLES, APPROACH & METHODOLOGY

- 2. Bilateral to multilateral regulation of cross border transport

- 6. Variable Geometry


TRIPARTITE (COMESA, EAC AND SADC) TRANSPORT AND TRANSIT FACILITATION PROGRAM

The expected Key Results are:

- **Result 1:** Tripartite Vehicle Load Management Strategy Implemented;
- **Result 2:** Harmonised Tripartite vehicle & driver regulations & standards implemented;
- **Result 3:** Tripartite transport registers and information platform system (TRIPS) implemented;
- **Result 4:** Efficiency of regional transport corridors improved.

Institutional Framework

- TTTFP is underpinned by signature of 2 multilateral agreements
 - Vehicle Load Management Agreement (VLMA)
 - Multilateral Cross-Border Road Transport Agreement (MCBRTA)
- Agreements have been adopted by Tripartite
 Ministers for Infrastructure on 31 October 2019
- Constitutional obligations of Member States following signature of International Agreements
 - Ratification
 - Domestication

Project Fundamentals

- Implementation of Multilateral Agreements requires domestication of range of enabling legislation
 - Vehicle Load Management Model Law
 - Road Traffic (Vehicle & Driver Quality) Model Law
 - Cross Border Road Transport Model Law (including Liberalisation & Operator Responsibilities)
 - Transport of Dangerous Goods by Road Model Law
 - Road Traffic & Transport Transgressions Model Law (including Decriminalization & Adjudication in accordance with Administrative Law)
 - Model Laws/ Principles have been adopted by Tripartite Ministers for Infrastructure on 31 October 2019

Project Fundamentals

- Multilateral Agreements introduce <u>quality regulation</u> of cross border road transport & require domestication of range of compulsory harmonised standards
 - Vehicle Safety, Dimensions & Equipment
 - Load Control & Weighbridges Calibration & Accreditation of Weigh Stations
 - Transport of Dangerous Goods by Road
 - Vehicle Fitness Certification Vehicle Testing & Evaluation/Grading of Test Stations
 - Driver Licensing Driver Training & Evaluation/Grading of Training Institutions & Testing Centres
 - Operator Authorisation Assessment of Quality of Operations

Decisions of the 2nd TSMCI Meeting 28-31 October 2019, Lusaka Zambia

- 1. Tripartite Ministers approved the VLMA & MCBRTA
- 2. Tripartite Ministers approved the 5 Model Laws
- 3. Opposition to abolishment of 3rd Country Rule not supported by all Tripartite Member/Partner States a study on transport operating environment in Zambia to be performed in support of Derogation Application
- MCBRTA should allow quality regulation for passenger transport within a market access regulated environment – TA to draft Exemption Application
- 5. Urged Member States to participate in TTTFP by allocating resources and appointing FPs & Alternates
- 6. Urged MS expedite Corridor Agreements & apply transit instruments.

- Develop qualifications framework, training curricula, training material & Procedures Tool-Kit – January 2020 to March 2021
- Develop & Implement National Transport Information System modules and TRIPS – October 2019 to March 2021

 - a) Vehicle Testing Stations
 - b) Driving Test Centres
 - c) Weigh Stations
- 7. Select 2 corridors for implementation by Jul'20

- 9. Urgent Immediate Actions:
 - a) Setting of IAP Technical Committees for Legislation, Systems, Standards, VLM and PC.
 - b) Drafting of National TTTFP IAPs
